WHY CLIMATE CHAMPIONS + OUR PROJECT RESULTS

Climate change is the defining issue of our time. We have reached a pivotal moment in deciding our planet's future. The need to act, to limit the most damaging impacts of climate change, we need to reduce greenhouse gas emissions globally and adapt to the current and future changes in the climate.

The youth of today are growing up in a climate activist world, enacting and fighting for change. However, adults have not grown up with this knowledge of climate change and sometimes feel helpless as they lack the skills to enact any meaningful change to the climate crisis.

When researching the need for this project, we found that non formal training on climate change and SDGs is hard to find, and access is particularly lacking in local community settings. Similarly, biodiversity content is harder to find in formal and informal learning settings.

> There is no one-size-fits-all solution. Changes must arise from a communitycentred process of learning how to live sustainably and regeneratively in a particular locality with its ecological and cultural uniqueness.

The Climate Champions project partners are working on three key results

EMPOWERING BIODIVERSITY AND CLIMATE CHANGE COMMUNITY CHAMPIONS (project result 1)

This resource will upskill community champions to be positioned to create immediate social impact. A single Champion can create a ripple effect of biodiverse & climate change actions. Under the guidance of ADCMoura - Associação para o Desenvolvimento do Concelho de Moura, partners are working hard on putting final touches to a series of modules that bring six SDGs into focus in adult education.

OMMUNITIES IN ACTION: COMPENDIUM

You may have seen our call for contribution to 30 case studies. We are developing compelling case studies, collected from biodiversity and climate action changemakers at the community level throughout Europe. Practical and transferrable learning, you will be inspired to learn and take action.

THEORY OF CHANGE TOOLKIT for COMMUNITIES (project result 3

Will equip participants to lead their community group through series of climate change and biodiversity specific steps to define long term goals, identify measurable indicators of success, and then work back to formulate actions and the 'mini-steps" that must be taken to achieve those goals.



SPOTLIGHT ON LEAD PARTNER ROSCOMMON LEADER PARTNERSHIP

Roscommon Integrated Development company (also known as Roscommon LEADER Partnership, RLP, and RIDC) is non-governmental organisation that works for the betterment of the people of County Roscommon, Ireland. This is a very broad remit, having a role in such diverse subjects as tourism, enterprise, environment, recreation, social inclusion and assistance to the unemployed to name but a

RLP and its predecessor organisations have actually been around since 1991, supporting communities and individuals in County Roscommon. We provide practical and needed supports including grants, training, work placements and advice. We work with community and voluntary groups, marginalised groups, small businesses, farm families and businesses and potential entrepreneurs. We also collaborate with a wide range of local organisations in the delivery of our services.

RLP is proud to support the work of many biodiversity conservation, climate change adaption,

and climate change mitigation initiatives. Through LEADER we fund communities to create environmental studies and action plans.

In 2019 we created a pilot training project as the first step in the delivery of biodiversity content in our adult community training. The aim of the pilot was to help communities to focus on natural and created habitats in their local area and give them sufficient capacity and knowledge to be engaged stewards of these habitats.

This programme supported 15 community groups in Roscommon to learn about biodiversity, habitat conservation, protection and development and habitat mapping. This programme was successful but limited. It showed us that the interest is there, and that more communities than ever need access to high quality training about biodiversity and climate change.




Castlecoote Tidy Towns was re-activated in the 1980's. From that time, the group have gone from strength to strength, winning two environmental awards, two bronze, three silver and six gold medals. For three years in a row, 2016/7/8, came 1st in Roscommon. In 2019, they again received a gold medal and increased their overall score by 4 marks. In 2013 the village received the major award of winning the Tidiest Village and Small Town in Ireland.

Castlecoote Tidy Towns is a vibrant and hardworking community group representative of a variety of interest from throughout the community. This group has been instrumental in voluntary community activities for the past number of years and is supported in its endeavors by Roscommon County Council, CE Scheme and Sesame Construction. The group has also successfully completed work on the Old Mill Wheels and the development of the Island on the River Suck. This group has good experience in dealing with funding applications.
